



**Connecticut Sun Munchkin Dance Team
Audition Release Form**

Section I:

For good and valuable consideration, receipt of which is hereby acknowledged, I hereby release and hold harmless the Mohegan Basketball Club, LLC. ("MBC"), Connecticut Sun, Mohegan Tribal Gaming Authority d.b.a. Mohegan Sun ("Mohegan Sun"), the Women's National Basketball Association and member teams, WNBA Properties, Inc. and their respective parents, subsidiaries, affiliates, directors, offices, governors, employees, and agents from and against any and all claims, cause of action, or demands relating to or arising out of my performance as a candidate during the Connecticut Sun Munchkin Dance Team audition process ("Process"). The Process includes a single audition scheduled for applicants on March 25, 2012, held at Mohegan Sun in Uncasville, CT.

I expressly assume all risk of injury (including permanent disability and death) arising out of my performance and participation in the Process, howsoever caused or arising and accept personal responsibility for the damages following such injury, permanent disability or death. I have no knowledge of any physical impairment that would be affected by the named dancer's participation in the audition Process.

I grant full and absolute permission to the MBC, Connecticut Sun, the Women's National Basketball Association, WNBA Properties, Inc. and WNBA Entertainment, Inc. their agents, and others working for them or on their behalf and their respective licensees, successors, and assigns (collectively the "licensed parties") with no obligation to compensate me further, to use, publish, broadcast, and copyright any photographs, videotapes, motion pictures, recordings, vice recordings, name, or likeness or other record of my performance(s) and participation in the audition process, or any material based or derived there from, or to refrain from so doing, in any manner or media whatsoever for purposes of advertising or trade in promoting and publicizing the Connecticut Sun. I shall have no right of approval, no claim to additional compensation, and no claim (including, without limitation, claims based upon invasion of privacy, defamation, or right of publicity) arising out of any use, alteration, distortion, or illusory effect, or use in any composite form.

Section II.

I hereby irrevocably consent to indemnify and save harmless MBC, Mohegan Sun, Connecticut Sun and their respective parents, subsidiaries, affiliates, directors, offices, governors, employees from and against any and all liability, claims, demands, damages, expenses, fees, fines, penalties, suits, proceedings, actions, and costs of any actions, including attorney's fees, court costs and other costs and expenses of any kind and nature arising or growing out of or in any way connected with my voluntary participation in the Process.

I have full authority to execute this General Release and do so with full knowledge of the facts and circumstances surrounding contractors.
